The ADA and 504 generally apply to persons with ‘an impairment that substantially limits a major life activity.’

Learning disabilities may occur in the following academic areas: Language, both spoken and written (often difficulties with reading, writing and spelling); and, Arithmetic (difficulty in performing arithmetic functions or in comprehending mathematical concepts). As many as 80% of all people with learning disabilities have dyslexia.
