Around June 2018, we wrote about the case of Castro-Tum, where it was held that Immigration Judge's (IJ's) and the Board of Immigration Appeals (BIA) do not have the general authority to suspend indefinitely immigration proceedings by administratively closing a case. Therefore, administrative closure is not something that is generally available in court as of now.
